array of physiological sensor placed at the steering wheel will continuously monitor the heart rate of the driver and based on the machine learning algorithms; the processor will identify the drowsiness of the driver.

Step 2:

A small camera will be positioned in front of the driver behind the steering wheel, which will capture the images of driver's eye at regular intervals of time and will also monitor the driver's head movement. Then the image will be processed in the processor where it will perform pattern recognition of the acquired data and determine if the driver is drowsy or not.

Step3:

Based on the output of Step1 and Step 2, the processing unit backed by some suitable machine learning algorithm will decide the driver's drowsy state.

The project is divided into two modules, one for each modality used for drowsiness assessment. First Module involves ECG based method, where a prototype for drowsiness detection using palmar ECG is to be built. Four quarters of the project is dedicated for first module, next four quarter involves addition of the video-based method to the ECG based prototype built in the first phase. The complete drowsiness assessment system is proposed to be completed by the end of eight quarters as has been described in the project timeline.
