

** It may be mentioned that during the period under consideration – 2016 - 2021, this was the only occasion when such grievances were raised in the department.









- ④ The format for preparing the learning ^{outcomes} objectives of the various courses is also discussed for further necessary action.






The Students' Appeal Committee sat on 11/06/2018 and look into the applications of


1. EGB15001- Sneha Roy

The decisions is as follows:

1. Sneha Roy (EGB15001): The Result is 'A' in EG307 (Seminar Presentation), not 'B+'. There was typological error on the resultsheet hung on the Departmental Notice Board. It has been corrected and Grade 'A' is shown in the grade submission form submitted to COE, TU.
