





## Tezpur University Intellectual Property Rights Cell

Keeping up with the objective of reaching out to the academic institutions of the region, a day long programme on Intellectual Property Rights Awareness was organised on 20 February 2020 at Nowgong College, Nagoan. This programme aimed at familiarising the students about the Intellectual Properties that they come across in their day to day life. The programme was jointly organised by Tezpur University Intellectual Property Rights (TUIPR) Cell along with the newly instituted Technology Enabling Centre (TEC), Tezpur University, and the Institutional Innovation Cell (IIC), Nowgong College. The main objective of the programme was to boost innovation among the college goers. More than 100 students from Nagaon participated in the programme.

The programme started with the welcome address by the Principal, Nowgong College, Dr Sarat Barkataki. Later, importance of innovation was put forth by Prof. Charulata Mahanta, from the Department of Food Engineering and Technology (FET), and Coordinator, TEC, Tezpur University. Prof. Pritam Deb, Coordinator, TUIPR Cell and member, TEC, briefly apprised the audience about the importance of protecting Intellectual Property and how it works for the advantage of the creators. Similarly, importance of identifying IPRs during various stages of innovations were put forth Dr. Partha Pratim Dutta, Associate Professor, Mechanical Engineering, and Member, TEC, Tezpur University. Prof. Manuj Kumar Hazarika from the Department of FET, and Co-Coordinator, DST-TEC, delivered the vote of thanks. He also elaborated on the importance of Institutional Innovation Cell (IIC) in colleges in his concluding note.

This made way for the first technical session of the workshop on the "Introduction to Intellectual Property Rights". A brief video was played on the theme "IP is everywhere" that was specially designed by CIPAM, under the Ministry of Commerce and Industries, Govt. of India.

The first technical session was aimed at giving a preliminary and simplified idea about what is Intellectual Property and how Intellectual Property Rights (IPRs) are important for all of us. Discussing different tools of IPR that are required for protecting various forms of IPs, Prof. P. Deb further elaborated on what one can do to prevent violation of IPRs. During his deliberation, he touched upon Patents, Copyrights, Industrial Design Registrations, Geographical Indications and Trademarks citing examples from various popular products that one uses use daily.

The second technical session dedicated on "Geographical Indications and its implication on communities", which was taken up by Dr. Juri B. Saikia, Research Officer, TUIPR Cell. In this session, the audience was apprised on the concept and purpose of having GI products registered in the GI Registry of India. It was further discussed how with the latest initiative of introducing a common logo for all GIs across the country, the Ministry of Commerce and Industries is trying to boost the rural economy by providing a special identity to the regional products associated with specific geographical areas across the country.

Stressing specifically on the products getting the status of GI from the North Eastern region, the discussion made way for the analysis of the latest inclusions in the registered GI's list. The requirement for establishing the proof of origin was discussed. Some popular case studies like GIs on Roshgulla, pending application and associated controversies of two states with Mysore Pak were also taken up. In this technical session too, an animation created by CIPAM on GI was shown to the audience for better understanding of the concepts.

The technical sessions witnessed very active participation from the students. After the lunch, the session was opened for interaction in a more structured way by means of organising an IP Quiz. In this Open House Quiz, questions were framed very tactfully so that all the facets of IPRs are touched upon effectively, without having the feel of the complexities and technicalities associated. The students were encouraged to ponder upon some of the hidden but very important IPRs and associated issues. Overwhelming participation was witnessed from the

students. The Quiz session lasted more than an hour, which was conducted by the renowned Quiz Master of Assam, Mr. Ashutosh Das. In between the Quiz, whenever there was a doubt among the participants about a concept that was dealt by any question, the speakers were pulled in to give the explanation for the same. The instant gratification of their curiosity made way for intellectual contentment. The verbal feedback received from the participants was very encouraging as many had not heard about IPR earlier, however after the session, they could very well connect with the concept. This was also evident in their active participation in the Quiz.

### About the Speakers:

#### **Pritam Deb**

Prof. Pritam Deb is the Coordinator of IPR Cell, Tezpur University and holds position of Professor in the Department of Physics, Tezpur University (Central University). He was a Max Planck Fellow of Max Planck Institute of Iron Research, Dusseldorf, Germany. He did his Ph.D. in Nanoscience from Jadavpur University and his research achievements include five applied patents and two granted software copyrights, besides numerous research papers in reputed journals. During his tenure as Coordinator of the IPR Cell, he has spearheaded many innovative IPR activities in the campus -- Best Innovative Idea Competition, IPR Quiz, IP Day Talk etc as part of World IP Day Celebration.



Besides teaching technical nuances to the students enrolled for the courses on IPR, he has also been working for initiating many industry academia research collaborations as part of the efforts initiated for creating a Pro- Industry research platform in the University. He envisions and has been working towards transforming TUIPR Cell into a prime facilitating center for IPR related issues for the entire North East region.

#### **Juri Borbora Saikia**

Dr. Juri Borbora Saikia graduated in science and obtained her postgraduate and Ph.D degrees from Tezpur University. She also holds a Post-Graduate Diploma in IPR Laws from the National Law School of India University, Bangalore. After working in IIT Guwahati as Senior Research Fellow from 2009 to 2011, she joined the prestigious MHRD Chair on IPR in Tezpur University as Research Officer in 2011.
