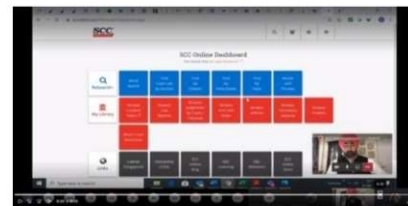
### Report: Workshop on Remote Access and Legal Research

Organized by: Department of Law, Tezpur University, Napaam

In association with SCC Online, 12<sup>th</sup> June, 2020

SCC training session for faculty members and students of law department, Tezpur University was organized on 12<sup>th</sup> June, 2020 from 10am to 11.30 am. The resource person was Chetan Singh Gill who is senior manager, Eastern Book Company, South Delhi. The resource person has extensively discussed the scope and opportunity available to law students and utility of SCC online in catering need of various job office requirements. Acts, Statues, Rules, Regulations, Order, Notification, Cases laws and secondary sources like articles, reports etc. are life blood for legal research. Audience were appraised about use of word search, find case law by section, find citation, find cases by party name, find materials by words and phrases. Participants were trained to have remote access of sconline data base which was the basic requirement during Covid-19 pandemic condition. Students and faculty members were trained to have remote access by the use of MYLOFT software. The head department of law was asked by the presenter to submit list of students and faculty members with detailed information about their contact number and mail ID and students were given remote access.

The presenter has discussed the option available to create their own folder to save search material and how to use references of supreme court cases in their research work. Importance of committees and commission reports was also provided. Articles published in more than 50 journals can be accessed through SCC online. Most importantly participants were told about filtering of search result to get appropriate result. Students and faculty members expressed their desire to hold such training session twice or thrice in an academic year to get better insight to legal research with the help of sconline data base.
