MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter called as MoU) is made on 19<sup>th</sup> day of February, 2018 between

Department of Business Administration, TEZPUR UNIVERSITY, Sonitpur, Assam, hereinafter referred to as TJBA

AND

Federation of Industries & Commerce of North Eastern Region, hereinafter referred to as FINER, Swahid Dilip Chakraborty Path, R.G. Baruah Road, Guwahati-78 1024, Assam, which is a registered Association representing Industry and Commerce of North Eastern Region, of the Second Part.

TUBA and the FINER are hereinafter respectively called as First Party and Second Party.

Whereas the parties hereto propose to enter into a Memorandum of Understanding (MoU) for the purpose of utilizing the services of each other to promote the cause of Industry and commerce in general and to promote micro, small and medium enterprises (MSME)/Large industries in particular and development of entrepreneurship of MBA Students through combined Activities.

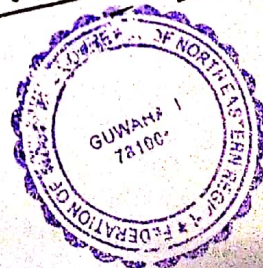
**NOW THEREFORE THIS MEMORANDUM OF UNDERSTANDING  
WITNESSETH AS UNDER:**

- 1) FINER will provide a list of its officials and its office bearers to TUBA and TUBA on its part will provide a list of concerned Officials of Tezpur University to FINER.
- 2) FINER would depute industrialists/ entrepreneurs/ managers as guest faculty from time to time to the Department of Business Administration, TU to share their industry experience with the students.
- 3) Department of Business Administration, TU would help industry with academic inputs required by them in addressing concerns and/or in solving issues/problems faced by FINER or their member industries.
- 4) FINER would provide and/ or facilitate collection of industry data required by TUBA for their various academic activities. However, it shall solely depend on particular industries and their willingness to share.
- 5) In the implementation of activities between both parties, a coordinator would be assigned from either party, for smooth communication.
- 6) TUBA shall provide literature and information related to Studies/Research Paper relating to entrepreneurship / industrial development to FINER.
- 7) FINER shall publicize TUBA literature and information in its Bulletin and its website, subject to availability of space.
- 8) TUBA and FINER will focus on the promotion of first generation entrepreneurs in the region. For this, both organizations will jointly conduct awareness programs and workshops.
- 9) TUBA would conduct relevant study covering economic aspects and would prepare case studies either severally or jointly as a teaching aid for benefit of students and FINER would facilitate the same wherever feasible.
- 10) For programmes jointly organized by TUBA and FINER, the participants of such programme may be awarded certificates issued by TUBA and FINER
- 11) TUBA and FINER will jointly arrange visits of students to plants belonging to FINER's members.
- 12) TUBA shall provide opportunities to members of FINER and their executives to take part in management development programs at mutually agreed fees.
- 13) TUBA and FINER would jointly organise events/seminars/workshop etc. in line with its objectives, more particularly for promotion of industrial development and scientific management practices in the region.

14) As and when any event is to be facilitated and organized in association with FINER, where funds are exclusively arranged by FINER, a facilitation fee would be payable to the FINER Secretariat depending on the nature and scale of the event. The fee will be mutually discussed and agreed between both parties on case to case basis.

15) Any information passed on by FINER to TUBA about its members and their activities will not be shared with the third party/parties by TUBA without the written consent of FINER and vice versa.

16) For any event organized by either party where participation of the other party is solicited, a reasonable period of notice is to be given. The invitee party shall try to participate in the event subject to availability of Directors /Authorized members /Officials/Faculty/Students.

17) Assistance/Collaboration of other departments/centres of the University will be available in specific cases wherever needed.

18) The conditions set forth herein can be modified by mutual consent of the TUBA and FINER in writing.

19) The term of the period may be 3 (three) years with an exit option by either party with a notice of three months.
