

MEMORANDUM OF AGREEMENT

This Agreement is made on this **15 Day of March 2021** between the Tezpur University, Tezpur.

AND

HQ 4 Corps, PIN-908504 c/o 99 APO.

WHEREAS the Tezpur University, Tezpur is conducting a Semester Certificate Programme on Chinese and HQ 4 Corps is desirous of admitting its persons subject to Army Act in the said course.

NOW THEREFORE THIS AGREEMENT WITNESSES AS UNDER: -

1. Candidates deputed by HQ 4 Corps shall be allowed admission to the regular 01 (one) semester certificate programme on Chinese Language of the Department of English & Foreign Languages of Tezpur University. These candidates will be called "Army Sponsored Candidates" (ASC).

2. The ASC should fulfil the eligibility criteria for admission of students fixed by Tezpur University for the Programme in consultation with HQ 4 Corps.

3. The ASC shall have to qualify a Selection Test similar to the one adopted by Tezpur University. The test will be conducted by HQ 4 Corps.

4. The HQ 4 Corps shall submit to Tezpur University the list of the candidates selected for admission to the programme by 15 March 2021.

5. The selected candidate shall be required to fill-in the Tezpur University application form which is available on payment of the prescribed price.

6. The HQ 4 Corps shall deposit all necessary fees of all the ASCs as Block Fees which is inclusive of cost of reading/ course material. The block fees shall be remitted as under:-

(a) **Initial Fee: Rs 1,00,000/- (Rupees one lakh only)** to be paid prior to commencement of course.

(b) **Balance Fee: Rs 2,75,000/- (Rupees two lakh seventy five thousand only)** to be paid in two instalment of Rs 1,37,500/- (Rupees one lakh thirty seven thousand five hundred) each in April 2021 and May 2021.

7. Initially, the ASCs shall attend the same course designed for the regular certificate course for the Tezpur University students along with them.

8. Tezpur University shall design customised course on Chinese Language on modular forms (on the basis of requirements of the Army) for enabling the successful students to undertake higher level courses based on feedback of Pilot Course.

9. The maximum number of ASCs shall not exceed 15 (fifteen).

10. The ASCs shall be issued with Tezpur University Identity Cards with validity for the duration of this course.

11. The ASCs shall be allowed to use all other general facilities available at Tezpur University as any other student is entitled to.

12. The ASCs shall fall under day Scholars category as they may not require the hostel facilities.

13. Arrangement for transportation of the ASCs to and from the University shall be made by the HQ 4 Corps their own arrangement.

14. The ASCs shall be guided by the rules and regulations of the University. Violation of such rules and regulations will attract disciplinary action as per University rules.

15. The Memorandum of Agreement (MoA) shall be done by the authorised officers of Tezpur University as well as the HQ 4 Corps, c/o 99 APO. This MoA shall be valid for Pilot Course starting from 15 March 2021 to 12 Jun 2021. The MoA may be renewed on the basis of the requirement of the Corps HQ and on approval of the University.
