MEMORANDUM OF AGREEMENT ON ESTABLISHING AN AWARD IN MEMORY OF LATE TILOTTAMA BAROOAH, A WOMEN ACTIVIST OF THE LAST CENTURY, FREEDOM FIGHTER AND AN ASSOCIATE WORKER OF THE DOYEN OF WOMEN ACTIVIST PADMASHREE CHANDRAPRABHA SAIKIANI, THE OUTSTANDING, FIRE BRAND WOMEN FREEDOM FIGHTER OF THE COUNTRY.

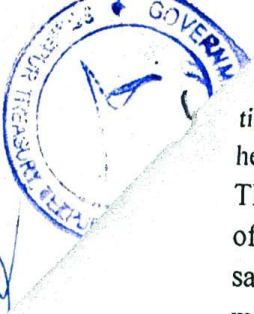
The Tezpur University (a Center University) situated at Napaam in Tezpur of Sonitpur District of Assam represented by its Registrar by virtue of their office (hereinafter called the University as the FIRST PART

And

Smt. Punya Barooah, daughter-in-law of freedom fighter late Tilottama Barooah and wife of Sr. Journalist Sri Apurba Barooah, aged about 86 years, resident of Golaghat Town, Old Amolapatty, a retired teacher (hereinafter called the TRUSTEE as the SECOND PART)

WHEREAS the SECOND PART has proposed for establishment of an Award with a one-time deposit of Rupees fifty thousand (Rs. 50,000/-) only (the receipt whereof the FIRST PART hereby admit, acknowledge and confirm) saved out of the political sufferers' pension of late TILOTTAMA BAROOAH, wife of Lt. Janapriya Moheswar Barooah, an outstanding lawyer of the last century and a renowned freedom fighter and put them in effective control over the same for investment thereof and apply the income exclusively for the objective hereinafter mentioned.

And whereas the FIRST PART has agreed to accept the proposal of the SECOND PART to be implemented through the Centre for/ Department of Women Studies of the University.


Now this agreement witness and it is hereby agreed and declared between the parties as follows:

1. The said sum of Rs 50,000/- only deposited by the Trustee shall be known as the late Tilottama Barooah Memorial Trust fund.
2. The University shall invest and at all time keep the said sum of Rs 50,000/- (Rupees fifty thousand) only in approved securities prescribed under section 20 of the Indian Trusts Act, 1882 and apply the income thereof in perpetuity for giving an award to a woman activist, nominated by jury constituted by the University in a 03(three) years period. Tezpur University's Chandraprabha Saikiani Centre for Women Studies Scheme will also conduct late Tilottama Barooah Memorial Lecture etc. as a University's programme from time to time all through with intimation to the Trustee or her nominee/nominees duly notified.
3. The University shall, out of the income of the Trust Fund i.e. interest receivable from the investment as fixed deposit in a nationalized bank, will utilize for the award as above referred under the banner of Chandraprabha Saikiani Centre for Women Studies.
4. A Managing Committee for the above purpose will be constituted by the Hon'ble Vice-Chancellor of Tezpur University, Napaam, Tezpur in consultation with Chandraprabha Saikiani Centre for Women Studies. The Trustee Smt. Punya Barooah, Dhansiri House, Golaghat-785621, or her nominee will be a member of the Managing Committee for administering the fund and conduct the Award.


