Dear Madam/Sir

In pursuance to the Judgement of the Hon'ble Supreme Court of India dated 08.05.2019 in Civil Appeal No. 887/2009, the UGC had notified ' Regulation on Curbing the Menace of Ragging in Higher Educational Institutions,2009 (D.O. No. 1-15/2009(ARC) pt.III dated 27 June,2019) which are available on the UGC website i.e.www.ugc.ac.in.

In this regard, I would like to inform you that the University has geared up its preparedness to stop any nuisances like ragging at the commencement of the new Academic Year 2019-20. Anti-Ragging Committee and Anti Ragging Squad are already in place and detail programmes like ice breaking sessions and surprise visits etc. are being chalked out.

As multiple mechanisms are required to ensure a ragging free campus, I would like to request you for taking the following measures at your departmental level:

- a. Allotting 'Teacher Mentor' to each of the fresh students of the Department. The list of Mentors is to be notified at the first week of the beginning of new session.
- b. Organizing 'Ice Breaking' sessions in the Department within the first few days of commencement of classes. These sessions are to be monitored by at least one member of the faculty by being present throughout the session these will be in addition to the hostel level session. The basic objective of such exercise is to build a sense of camaraderie and to give a feeling of the culture, ethos and tradition of the University and that of the Department to the newcomers.
- c. Constituting 'Departmental level Anti Ragging Cell'. The names of the members of the Departmental Anti-ragging cell should be intimated to the undersigned on or before 25/07/2019. Ideally the HoD should be the Chairperson of the Cell, and teachers, technical staff and senior students' (at least two) may be included as members. The members of Departmental Anti-ragging Cell will monitor and stop any occurrence of ragging within or outside the Department. The Cell will submit report periodically to the Chairperson. The Cell should address the students, in your presence, on the very first day of the session.

You are requested kindly to motivate your students to report any incident/attempt of ragging immediately so that corrective measures could be taken up.

You are also requested to prepare a detail programme of ice breaking sessions of your department and arrange for circulating the same among the newcomers at the time of admission. A copy of the ice breaking programme may kindly be forwarded to the undersigned for our record.

Kindly feel free to suggest any other measure that you think helpful in curbing ragging.
