Dear Sir,

Please refer to our telephonic conversation regarding organizing an Online Quiz competition among the students of Tezpur university on Gandhian Philosophy as a part of 150th Birth Anniversary Celebration of Mahatma Gandhi on or before October 2, 2020.

The competition may be organised under the banner of Tezpur University Ek Bharat Shrestha Bharat, Mental Health Task Force and NSS cell.

I had a talk with our alumnus and renowned quiz master Ashutosh Das for conducting the quiz. He readily agreed and said that he will charge RS. 3000/- per session.
