Case I :

The meeting discussed the disciplinary case of Mr. Prachurjya Pratim Neog, Roll No. CSI15023 and Mr. Gyanankur Das, Roll No. BAM15035. Details of the report of the security officer on this matter is placed at **Annexure-I**.


The Dean, Students Welfare reported the members that these two students were coming from outside in heavy drunken state at midnight of 14th February, 2017 (at about 00.30 hrs. of 15 .2.2017)and they were allegedly beaten by some persons outside the campus. The students also alleged that they were beaten by the outsiders in front of security persons when they came inside the main gate. The Dean, Students Welfare also informed that he, Registrar and Security Officer rushed to the main gate when the students were hold by the security persons in the main gate. The Dean, Students Welfare also informed that Mr. Gyanakur Das tried to mislead him by providing wrong information about his name, department, hostel name etc.

Resolution:

After thorough discussion the meeting noted that the students created bad impression in the local society about the University and recommended the following penalty :

1. Rustication from hostel for the current semester
2. Stern warning letter be issued to the students with a copy to their parents
3. More stringent action be imposed if they will involve indulging in breaking discipline/university rules in future.

The Registrar may be requested to look into the allegations of the students that they were beaten by the outsiders in front of the security persons inside the main gate.

After receiving the positive response from the Heads of the department the Dean, Students Welfare may place the matter to the Vice-Chancellor for his consideration of approval.

The meeting was presided over by Professor D. Deka, Dean, Students Welfare. At the very outset, Prof. Deka welcomed the members. The meeting discussed the report of Security Officer on the matter of alcohol consumption by TU Students and entered the TU main gate on 25th February, 2017 at about 8-45 pm in very high speed by Alto car No. AS12 F 1442. The following students were found involved in the incident:

- (i) Mr. Niharjyoti Gogoi, B.Tech (Civil), 6th Semester (Roll No. CIB 14028)
- (ii) Mr. Sandip Gogoi, B.Tech (ME), 6th Semester (Roll No. MEB 14040)
- (iii) Mr. Siladitya Buragohain, B.Voc (Food Processing), 2nd Semester (Roll No. BVF 16016)
- (iv) Mr. Bhintu Moni Deory (2016 passed out student, B.Tech, CIVIL)

The alleged students except Mr. Bhintu Moni Deory were summoned by the committee and interacted with them. Students gave undertaking on their involvements in the incident. After hearing out the students and discussion on the report, the Committee found that the Mr. Niharjyoti Gogoi and Mr. Bhintu Moni Deory were in heavy drunken state. Mr. Nihar Gogoi was also alleged for using foul language with unruly behavior to the University officials who attended the spot at the time of the incident in the main gate. Though the drunken state for other two students, Mr. Sandip Gogoi and Mr. Siladitya Buragohain could not be ascertained, but Mr. Siladitya Buragohain was the owner of the car and Mr. Sandip Gogoi drove the car and brought it inside the main gate in very high speed ignoring the repeated signals of security personnel as reported by Security officers of the University. Two wine bottles were also seized from the said car. After the threadbare discussion, the committee recommended the following punishment.

(a) Punishment recommended for Mr. Niharjyoti Gogoi :

- (i) Rustication for two semesters (current & next semester) from hostel
- (ii) Conduct probation for two semester (current & next semester)
- (iii) Strong warning letter be issued to him and information to parents

(b) Punishment for Mr. Sandip Gogoi and Mr. Siladitya Buragohain

- (i) A fine of Rs. 5000/- each
- (ii) Strong warning letters be issued
- (ii) Information to the parents

As Mr. Bhintu Moni Deori is an ex-student of the University, the committee recommended that he would not be allowed to stay in the hostel in future.

In view of using four wheelers by the students on the campus, the Registrar be requested to streamline the using of vehicle by the students.

Mr. Niharjyoti Gogoi (CIB14028) a boarder of PMH was caught red-handed while he attempted to enter through main gate in heavily drunken state with other three students on 25th February, 2017 at about 8:45 pm by sitting in a very high speed Alto car. Mr. Gogoi was also alleged for using foul languages with unruly behavior to the University officials who attended the spot at the time of the incident in the main gate.

Based on the recommendations of Students' Disciplinary Committee, the competent authority imposed the following punitive actions on him:

- Mr. Niharjyoti Gogoi is rusticated from the hostel for two semesters (current & next semester). He shall vacate the Hostel room on or before 20.03.2017. However, he will be allowed to return to the hostel after the completion of the period.
- Mr. Gogoi is put under conduct probation for two consecutive semesters (current & next semester) from the date of issue of this order. During the conduct probation he will not be allowed to:
 - (a) Represent the University in Sports, Cultural contests etc. inside or outside the University.
 - (b) Receive any scholarship, fellowship or stipend and the loss entailed will be permanent and no arrears shall be payable subsequently on expiry of the period of the conduct probation.
- More stringent action will be imposed if he is found involved in violating any discipline/University rules in future.

The meeting was presided over by Professor D. Deka, Dean, Students' Welfare (DSW). At the very outset, Prof. Deka welcomed the members.

Case I: DSW informed that during his regular visit to Kanchenjunga Men's Hostel he found some amount of Ganja along with a smoking device in the room no. 404 of the hostel at about 9.00 p.m on 10.08.2017. Mr. Debanga Rajkhowa (Roll No. BVE17008), a 1st semester student of B.Voc programme (who resides in the room) informed the DSW that some of his friends Viz., (1) Mr. Nitin Ghosh (Roll No.BVE17001), a boarder of KMH, (2) Mr. Kailash Protim Kalita (Roll No.BVE17007) , boarder of Transit Men's Hostel and (3) Mr. Swaraj Bharali (Rollno. BVE17010) of Transit Men's Hostel used to visit his room quite often in the evening time and take the ganja through this device. Mr. Rajkhowa also handed over some tobacco leaves to the DSW during his visit to the hostel.

All the above students were summoned by the committee and enquired about their involvement of smoking of ganja. Mr. Debanga Rajkhowa stated that he never smoked, but one day he tasted with others in his room. Other three erring boarders confessed that they used to smoke ganja in that room. Mr. Swaraj Bharali informed the committee that he used to smoke ganja earlier also before coming to this University. All of them submitted separate written confession (undertaking) with apology.

The Committee discussed the matter thoroughly and found that the three boarders viz., (1) Mr. Nitin Ghosh (2) Mr. Kailash Protim Kalita and (3) Mr. Swaraj Bharali breached the hostel rules by bringing intoxicants in the hostel and smoked the banned item. Although Mr. Debanga Rajkhowa said that he did not smoke ganja/tobacco in the room except one day, the committee could not find a reasonable point that he was not involved. The committee found him equally



guilty for allowing his friends to smoke in his room. On the other hand, he did not inform the matters to the hostel authority. The committee also discussed that all of them had completed their HS examinations and just joined the University for their UG programmes. Considering their future career and nature of offence they committed the committee recommended the following punishment as per existing University Hostel rules:

1. All the four students be imposed conduct probation for six months
2. Each of them be imposed a fine of Rs 5000/- only. They will deposit the fine in the finance section within 15th September, 2017 and submit a copy of the receipt to the DSW.
3. A stern warning letter to each of them to refrain from such unlawful activities in the hostel in future failing which stricter action will be taken against them as per hostel rules.
4. Their parents be called and apprise the situation.

Case II: the DSW informed the members that during the programme of General Fresher's Meet held on 17.08.2017 some students were found involved in fighting each other. The incident took place at about 9.30 p.m. outside the community hall. In this regard Mr. Ranjeet Kumar (Roll no. CIB 14058) lodged a written complaint to the DSW against Mr. Bibek Bachhan Baruah (Roll No. MS115009) and Mr. Rajesh Kumbang (Roll No. CSB14050) who fought with him and Mr. Bibek Bachhan Baruah hit him on his nose injuring seriously. DSW stated in the meeting that when he rushed to the spot he found that Bibek Bachhan Baruah was on drunken stage. Mr. Ranjeet Kumar was summoned before the committee to know about the incident.

The committee felt that this matter needed detailed deliberation and due shortage of time resolved to defer this item till the next meeting of the disciplinary committee is held.

The DSW welcomed the members and briefly informed that the meeting had been convened to take decision on the disciplinary case deferred by the earlier meeting held on 18.08.2017. He narrated the disciplinary case as below:

During the programme of General Freshers' Meet held on 16.08.2017, some students were found involved in fighting each other at about 9.30 p.m. outside the community hall. In this regard Mr. Ranjeet (Roll no. CIB 14058) lodged a complaint to the DSW against Mr. Bibek Bachan Baruah (Roll No. MS115009) and Mr. Rajesh Kumbang (Roll No. CSB14050), who fought with him and got injured in his nose. He had to be taken to the Health Centre for immediate treatment due to bleeding from his nose. The DSW informed that after having received the information of fighting between two groups he rushed to the spot. By this time the two groups were already separated by some other students. He confirmed that Mr. Bibek Bachan Baruah was on drunken stage at that time and was creating nuisance. Mr. Baruah also shouted at him amidst the gathering. Mr. Bibek was not in normal condition and some students were holding him to avoid escalation of the fighting. Mr. Rajesh Kumbang was also on the spot supporting Mr. Bibek Bachan Barua.

The committee summoned Mr. Ranjeet and Mr. Bibek Bachan Baruah separately in the meeting and heard from them about the incident. Mr. Rajesh Kumbang did not appear before the committee; however, he sent an apology letter through his friend Mr. Bibek Bachan Baruah for involving himself in the fighting.

After hearing from Mr. Ranjeet and Mr. Bibek Bacchan Baruah and going through the application of Mr. Rajesh Kumbang, the committee critically discussed the matter and noted the following:

1. The committee confirmed that Mr. Ranjeet was hit by Mr. Bibek Bachhan Baruah and Mr. Rajesh Kumbang.
2. Mr. Bibek Bachhan Baruah stated that he was also assaulted by some persons as a result he fell down and got injured. However, he could not tell the name who assaulted him. He confessed that he was in alcoholic intoxicated condition and misbehaved the DSW. He sought apology in the meeting. He also gave written apology statement.
3. Mr. Rajesh Kumbang was already rusticated from the hostel for the remaining period of his study in the University due to his earlier disciplinary case.

In view of above, the committee recommended the imposition of the following punishment individually:

(I) Punishment for Mr. Bibek Bachan Baruah:

- (i) Mr. Bibek Bachan Baruah be rusticated from the University hostel for the rest period of his study.
- (ii) He be put under Conduct Probation for the rest period of his study in University.
- (iii) He be not allowed to sit for campus placement.
- (iv) He be not allowed to visit any hostel of the University for the rest period of his study.
- (v) In case of violation of the above punishment he be summarily rusticated from the University.
- (vi) His parents be informed of his act of indiscipline and the punishment imposed on him.

(II) Punishment for Mr. Rajesh Kumbang:

- (i) Mr. Rajesh Kumbang has already been rusticated from the hostel and under Conduct Probation due to his earlier cases of misconduct and under observation of Disciplinary Action Committee.
- (ii) He be banned to visit any hostel.
- (iii) He be not allowed to stay on the campus after 9.30 pm.
- (iv) In case of violation of the above punishment he be summarily rusticated from the University.
- (v) His parents be informed of his act of indiscipline and the punishment imposed on him.

(III) Punishment for Mr. Ranjeet:

DSW welcomed the members and the committee discussed the complaint raised by six students and boarders of KMH against Mriganka Bharali, Dept. of EFL (Roll No. EGI15013), a boarder of KMH residing in Room No. 148 and Ritupal Sarma, Dept. of ECL (Roll No. ELB 14013), an ex-boarder of KMH, who has been rusticated from hostel as per office order no. TU/DSW/DC/14/12-10/256-A dtd. 18/12/2015. As per their application addressed to Warden, KMH that the above two students used to disturb the other students often regularly in the Wing by asking them to bring disposable glasses, water etc. required for alcohol consumption in room no. 148. As per the complainants, they used to throw garbage, urinate and vomiting in the corridor and thus, they were facing mental harassment. Similar complaints were also received sent by some students via e-mail on October 25, 2017 and November 10, 2017. The Warden and Associate Warden were informed accordingly. On the night of 27.11.2017 at 11pm during the visit by Associate Warden, KMH, Dr. Jayanta Vishnu Das, he found alcohol bottles and narcotic (Ganja) smoking device in the room no. 148. Complainants reported to Dr. Das that above two students were in the rooms that day also. Mriganka Bharali and Ritupal Sarma were summoned to the Disciplinary Committee. Mriganka Bharali appeared in the committee and Ritupal Sarma did not appear as he was absent and went to his home place.

After threadbare discussion, the Committee recommended the followings:

- i) Mr. Mriganka Bharali be shifted to other hostel from KMH with immediate effect to prevent him from further act of indiscipline in KMH.
- ii) Copy of office order be sent to the parent

As the compliant was received for mental harassment, asking other students to do act against their willing, the committee recommended to refer the matter to **the Anti-Ragging Committee** of the University according to the Clause No. 3 of the UGC Regulation on Curbing the Menace of Ragging in Higher Education Institutions, 2009 (under Section 26(1)(g) of the University Grants Commission Act, 1956) dtd. 17th June, 2009.

Similar complaints were also received sent by some students via e-mail against them.

Based on the recommendation of students' Disciplinary Committee, the competent authority imposed the following punitive actions on Mr. Bharali.

- i) Mr. Mriganka Bharali be shifted to other hostel from KMH with immediate effect to prevent him from further act of indiscipline in KMH.
- ii) Copy of office order be sent to the parent

Mr. Mriganka Bharali is hereby instructed to leave KMH on or before 7.12.2017 and can reside temporarily in TMH till the next office order of disciplinary action is issued.

Mr. Bharali is warned not to involve in any kind of such offence in future, otherwise, University would take stricter action against him as per rule of the University.
