

Meeting of the Disciplinary Committee held at 11.30 a.m. on 26.12.2017 in the Council Hall to discuss the report of the Inquiry Committee on the incidence that took place in the early hours of 6th November, 2017

Members present:

40 members were present (copy enclosed)

The Dean, Students Welfare requested the Vice Chancellor to Chair the meeting. The Vice Chancellor chaired the meeting and welcomed the members. The DSW requested Prof. Chandana Goswami, Chairperson of the Inquiry Committee to place their report on the incidence that took place after the cultural event of TechXetra 2017 on early hours of 6th November, 2017, before the Disciplinary Committee. Prof. Goswami informed the members that they prepared the report based on the CCTV footage, interactions with Registrar, DSW, Wardens, Prefects, Students, ex-TUSC members and present TUSC members. She said that the incident started with the "improper conduct" of a home guard (security guard of the University) with a girl student at around 11.30 p.m. on 5th November, 2017. During that time Mr. Devraj Mahanta was with the girl. Some girl students from the Transit Girl's Hostel and a few boys also arrived at the site. The accused home guard was identified by the Security Officer. Initially, it was decided that the girl would take up the matter with the University in the next day morning and she requested that the incident should not be made public. However, the boys went from the site to the Main Gate and demanded immediate action against the home guard. The Chairperson of the committee reported in detail how the students from the hostels were mobilised by a group of students to reach to the Main Gate. She also highlighted the unruly behaviour of a number of students, some of whom ~~also~~ also spoke to the media, involved in spreading false news, obstructing the Police Van, closing the Main Gate, not allowing the Police to take away the Home guard allegedly involved in 'improper conduct' (detailed Inquiry report is enclosed). The Inquiry committee reported that the following students were involved in the incidents as shown below:

The meeting discussed the report of the Inquiry Committee in detail and noted the involvement of the above students in the incident and held them responsible for damaging the reputation of the University. The meeting also noted the behaviour of the students during the incident on 6.11.2017 that they were not showing faith on the University administration as well as District administration. Further, refusal of the students to refer the incident of the girl to the Internal Complaint Committee (ICC) compelled the University to hand over the case to the Police which led to further harassment on the girl student and the entire matter became public.

Depending on the severity of the offence of the students the Disciplinary Committee recommended the following disciplinary actions against them:

Group A:

(1) The following students be rusticated from the University for two semesters i.e. Spring and Autumn semester, 2018:

- (2) They be put under Conduct Probation for the remaining period of their study.
- (3) They be not allowed to seat for campus interview for placement during the period of Conduct probation.
- (4) Stern warning letter to refrain from indulging in such activities in future be issued to them with intimation to their parents.
- (5) If they are found involved in any act of indiscipline they be imposed stricter action as per University rules.

Group B:

- (1) Taznin Hussain (EGL17007) and Kabir Prasad Deka (CIB15023) be rusticated from the hostel for rest of their study period
- (2) They be put under Conduct Probation for rest of their study period in the University.
- (3) Ankur Sahu (BBI13016) be rusticated from the University for one semester as he has already been rusticated from the hostel due to his earlier involvement in an act of indiscipline of misbehaving a boarder of PMH.
- (4) Stern warning letter to refrain from indulging in such activities in future be issued to them with intimation to their parents. If they are found involving in any act of indiscipline they be imposed stricter action as per University rules.
- (5) Stern warning letter not to visit the hostel in future. If they are found visiting the hostel they be rusticated from the University.

Mr. Kabir Prasad Deka and Gargi Sarkar, TUSC members may be asked to demit their office.

Group C:

1. Juman Hazarika (ELB15034), Tonmay Sharma (MEB15029) and Asif Ahmed (CIB16021) be rusticated from the hostel for remaining period of their study.
2. They be put under Conduct Probation for remaining period of their study.

3. Stern warning letter not to visit the hostel in future. If they are found visiting the hostel they be rusticated from the University.
4. Result of the Autumn Semester End Examinations, 2017 of Ms. Indrani Kalita (SOW15006) be withheld and declared only in the month of June, 2018.

CIB14054), a student of B.Tech in Civil Engineering programme, involved in the unruly incident that took place in the early hours of 06.11.2017 at the University Main Gate. Mr. Pandey was involved in obstructing University Administration in performing their duties, spreading false news about the incident with the intent to incite students, closing the main gate, irrational use of media, obstructing the Police vehicle from carrying the home guard allegedly involved in the act of misbehavior from the campus, dishonouring and defying the University Authority.

DSW welcomed the members and placed before the committee for discussion of two cases reported from Saraighat C. V. Raman Men's Hostel (SCVRMH) and Patkai Men's Hostel (PMH).

Case I: Prefect and Assistant Prefects of SCVRMH reported in writing through the concerned Warden that the following boarders were involved in drinking alcohol and taking *Marijuana* (ganja) in the Saraighat C. V. Raman Men's Hostel:

1. Mr. Rahul Buragohain (Roll No.MSB17005), a boarder of Transit Men's Hostel
2. Mr. Arunabh Buragohain (Roll No.MSI17010), a boarder of Charaideo Men's Hostel
3. Mr. Jiwajyoti Mahanta (Roll No.ENE16010), a boarder of S.C.V. Raman Men's Hostel
4. Mr. Rayhan Galib (Roll No.FPL16008), a boarder of S.C.V. Raman Men's Hostel
5. Mr. Ashutosh Anubhav (Roll No.MBM16020), a boarder of Nilachal Men's Hostel

Prefect and Assistant Prefects of SCVRMH found **Mr. Rahul Buragohain**, a boarder of Transit Men's Hostel in the bathroom of 3rd floor of Saraighat C. V. Raman Men's Hostel at about 11:00 pm on 02.12.2017 in senseless condition. **Mr. Arunabh Buragohain**, another boarder of Charaideo Men's Hostel was found sleeping in the room of **Mr. Jiwajyoti Mahanta** at the same time in highly intoxicated condition. Interestingly, Mr. Jiwajyoti Mahanta, who is senior to them, allowed them to sleep in his room as they were already intoxicated condition. He then left the room as he said. Finding the condition of Rahul Buragohain critical, Prefect called University Medical officer. As per report of the Prefect, the Medical Officer found them consumed alcohol and drugs together.

The Prefect and Assistant Prefects also reported that at the same time, **Mr. Rayhan Galib** and **Mr. Ashutosh Anubhav** were playing cards after holding alcohol party in another room. They found both of them in intoxicated condition. Details report and undertakings of the delinquent boarders were placed at **Annexure-I**.

 - (iii) Dr. B. Srivastava, Head, Department of Food Engineering and Technology
- B) The committee found the following five delinquent boarders of SCVRMH guilty on breaching the hostel discipline and tranquility.

 2. Mr. Rahul Buragohain (Roll No.MSB17005), a boarder of Transit Men's Hostel

- ❖ The meeting recommended that all five students be rusticated from the hostel with conduct probation for remaining period of their study:
 - ❖ If they indulge in such activities in future, they may be rusticated from the University.

Case II: The Warden, Patkai Men's Hostel reported that on 29th November, 2017 at 9:30 pm, five students namely Mr. Tonmoy Sarma (Roll No. MEB15029), Mr. Rajesh Kumbang (Roll No. CSB14050), Mr. Niaz Md. Dilwar Rahman (Roll No. WMS17009), Mr. Avinava Bora (Roll No. MEB17043) and Mr. Mriganka Bharali (Roll No. EGI15013) were found at Room No.350 of Patkai Men's Hostel with a *Bong* (device use to smoke cannabis) and cannabis fed in it. The room was smelling cannabis. They were smoking or trying to smoke the cannabis.

This is serious breach of hostel rule. Mr. Rajesh Kumbang, who was debarred from hostel, was also found in the Room No.350 of Patkai Men's Hostel. In earlier case he was warned that strict action would be taken if he found in and around university hostel. Still he visited the hostel and carrying out nuisance in association with other students.

Recommendation:

After thread bear discussion the meeting recommended the following:

- 1 **Mr. Rajesh Kumbang:** He was found to involve in violating hostel rules earlier also and he was banned from visiting any of the hostels. He was not allowed to stay on the campus after 9.30 p.m. Despite of this warning he visited the hostel and got himself involved in violating the hostel rules. **He be rusticated from the University for current semester.**
- 2 **Mr. Tonmoy Sarma:** He was also rusticated from the Hostel for the remaining period of this study for his involvement in the incidence of 06.11.2017. **Now, for this case he be rusticated from the University for one semester (current).**
- 3 **Mr. Niaz Md. Dilwar Rahman:** This is his first case of indiscipline. **He be issued stern warning letter asking him to refrain from such activates in future with a copy of the letter to his parents.**
- 4 **Mr. Avinava Bora:** This is being his first case, **he be issued stern warning letter asking him to refrain from such activates in future with a copy of the letter to his parents.**

- 5 **Mr. Mriganka Bharali:** He has already been rusticated from the University for one semester for his involvement in ragging. **He be issued stern warning letter asking him to refrain from such activates in future with a copy of the letter to his parents.**

Case III: The Warden of the Transit Men's hostel reported that the following two boarders were found consuming alcohol in the hostel on the night of 15.01.2018:




The Warden confiscated the alcohol bottle from the room.

The meeting was chaired by DSW. DSW welcomed all the members of the newly constituted Disciplinary Committee. The discussions and decisions of the meeting are as follows:

Case-I: Disciplinary matter of Mr. Jitartha Kumar Pathak (Roll No. BAM17076), Dept. of BA.

As per the request of the DSW, the COE briefly informed the members that Mr. Jitartha Kumar Pathak (Roll No. BAM 17076), a 2nd Semester student of MBA programme, misbehaved with Prof. M. K. Sarma by abusing and screaming at him in the classroom.

As per report of the DAC, Dept of BA , the incident took place towards the end of the last semester, i.e. on 14 May 2018 at about 10.15 a.m. When the incident took place Mr. Pathak was so aggressive that he would have physically attacked if the students of the classroom would have not caught hold of him. The CoE also informed that an FIR was lodged in the Police station as per the report of the Department, and also a show cause notice was issued to Mr. Pathak. It is also informed that the reply to the show cause notice of Mr. Pathak was not satisfactory to the University which have been communicated to him.

Prof. Chandana Goswami, Dean Management Sc. and Prof. Paporu Baruah, Head, Dept. of BA, also narrated the incident. They added that Mr. Pathak rang up to Dr. T. R. Sharma, one of the faculty members of the Department over phone on 15 June 2018 at 10.19 am and shouted threatening him and some other faculty members. The department has appealed to the University through DAC meeting held on 15 May 2018 to take safety measure.

The DSW read out the show cause notice served to Mr. Pathak from Chairman, Disciplinary Committee and reply of Mr. Pathak, appeal of his father, DAC resolutions of the Department etc. before the meeting.

After the threadbare discussion, the committee resolves as follows:

Resolutions 1:

1. The Committee re-affirmed the decision of the University that the explanation of Mr. Pathak to the show cause notice was not satisfactory and therefore, it was not acceptable.

2. Mr. Pathak might not be allowed to continue his MBA programme at this state of his inconsistent and violent behavior. The committee suggested for immediate medical treatment for Mr. Pathak.
3. In case of his selection for admission to other programme or if he requests for continuation in the same Department in future then he may be asked to produce a medical fitness certificate issued by Psychologist which may be verified by the Medical Board to be constituted by the University.

Case -II Appeal of Ms. Taznin Hussain (Roll No EGL17007) for allotment of hostel


Ms. Taznin Hussain was rusticated from the hostel for two semesters i.e. Spring Semester and Autumn Semester, 2018 due to her misconduct vide office Order No. TU/DSW/Disc/17-F.01/521-A dtd.-01.02.2018 (copy enclosed). She stayed outside the campus for one semester and appealed to the DSW to allow her to come back to hostel. The Head of the Department of EFL, Prof. M. Barbora who attended the meeting as special invitee told the house that Ms. Hussain is one of the good students in the department securing good marks and showing good behavior to all with honesty.

After discussion, the following resolution was taken unanimously:

Resolution 2:

After taking into consideration of her good academic performance in the last examinations, the committee recommended that she may be allowed to stay in the hostel subject to availability of the hostel seat. However, other punishment as imposed by the University office order No. TU/DSW/Disc/17-F.01/510-A dtd.09.01.2018 and TU/DSW/Disc/17-F.01/521-A dtd.- 01. 02. 2018 would be remained unchanged.

Dear Mr. Pathak,

Inviting a reference to the subject matter cited above, please be informed you that your reply dated 22.06.2018 to the show cause notice no. TU/Regr/Corres/2018/1215 dtd. 15-06-2018 is not acceptable to the University for the following reasons:


1. As reported by your class teacher, you were not attending your first class in the department most often. You have also accepted this in your above letter. Though teachers suggested you to correct this habit, you never tried to improve it. It seems you took it to be 'as granted' ignoring the need of attending classes regularly.
2. As per minutes of the DAC, Department of Business Administration, held on 15th May, 2018, all teachers expressed their concern on your unruly behavior in the department on 14th May, 2018 at about 10.15 am. This behavior was not expected and desired from a student studying in an institution of higher learning. But, no apology is evident at your above referred letter for this misconduct. Instead, without having any evidence, you alleged that teachers were doing partiality against you.
3. You have mentioned in your letter that all teachers awarded "F" grade to you in a planned manner so that you would be out of the course. If it was so, as per University evaluation system, you could have checked your examination answer scripts and could have approached the HoD or the Grievance Redressal Committee. If your request/prayer was not entertained, you could have approached the higher authority. Instead, you threatened faculty members and their family members by phone call to one of your teachers on 15-06-2018.
4. Considering all above, the Competent Authority of the University did not accept your reply. Accordingly, the university will proceed for further action as per rules.






