

**DISCIPLINARY COMMITTEE MEETING HELD ON 27.02.2019 AT 4.30PM IN THE PPT ROOM OF THE ADMINISTRATIVE BLOCK**

The meeting was Chaired by DSW. The DSW welcomed all the members and discussed the following agenda.

**\* Case-I: Review of the amount of fine imposed in the Disciplinary Committee meeting held on 21.12.2018**

The committee discussed the suggestion of the Vice-Chancellor to mention the specific rules in the minutes of the Disciplinary committee dated 21.12.2018 while recommending to impose Rs. 25000/- as fine to Mr. Rajesh Kumbang and Rs. 10000/- fine to Mr. Akash Hazarika (Roll No. CIB16075) and Mr. Debajyoti Kalita for breaching the hostel rules and violating earlier orders of Disciplinary Committee.

The committee observed that there is a clause 9.4.2 of the Hostel Rules for "imposition of a fine" to the major offence, but there is no mention of specific amount of fine for specific nature of offence.

There after threadbare discussion, the committee reviewed the available records of fine imposed by the Students Disciplinary Committee in previous cases of offence for last few years. The maximum amount of fine imposed has been found Rs. 10000/- only.

The committee considering the previous cases recommended the following:

- (i) Mr. Rajesh Kumbang (Roll No.CSB14050), who indulged in violation of the hostel rules repeatedly despite of several warning issued by the disciplinary committee, be imposed a fine of Rs.15,000/- as punitive action as per the clause 9.4.2 of the Hostel Rules 1915 as against earlier proposed Rs. 25000/-. This amount is proposed because there are instances of imposing a fine of Rs10,000/- in similar cases earlier. He may be issued strong warning letter with a caution note that further violation of the University rules will invite extreme punitive action.
- (ii) Similarly, the fine imposed on Mr. Akash Hazarika (Roll No. CIB16075) and Mr. Dibyajyoti Kalita (Roll No. CIB16046) be reduced to Rs.5000/- under the same clause stated above instead of Rs.10000/- as this is being their first case of such offence.

✓ **Case-II: Objectionable behaviour of Mr. Pranjal Barman, a Ph.D student of the Dept. of ECE, towards his guide Dr. Santanu Sarma, Associate Professor, Dept. of ECE (Annexure-II)**

Dr. Santanu Sarma, Supervisor of Mr. Pranjal Barman was out of station for academic purpose so could not attend the meeting. The Head, Department of ECE forwarded the minutes of the DRC dated 12.11.2018 recommending to take action against **Mr. Pranjal Barman** for his objectionable behaviour to his supervisor, Dr. Santanu Sarma. Mr. Pranjal Barman was called before the Committee and asked to give his statement. He has submitted his written statement to the Chairman of the meeting.

**Resolution:** After hearing from Mr. Barman, the committee recommended to refer the matter to the Deans' Committee meeting as the matter was related to PhD supervisor and student. The committee opined that the matter was beyond the purview of the Disciplinary committee to take a decision.

**Case-III: Ruckus created by some students in the night of 24.02.2019(Sunday) which was the last day of Annual meet.**

The DSW appraised the members about the following two cases of students' vandalism:

**Incident 1-** Mr. Rajesh Kumbhang (Roll No. CSB14050) B. Tech, Dept. of CSE, and Mr. Sujen Sen, (Roll No. CSB15016) 8<sup>th</sup> Semester, B.Tech, Dept. of CSE fought each other in the night of Annual Meet at about 9.15 p.m. on 24.2.2019 in the University play ground while the performance of invited artist was going on in the play ground. As reported, one of the feet of Mr. Sujen Sen put on the foot of a girl student, Ms. Sweeta Das, the friend of Mr. Kumbhang while they were enjoying performance of invited artist. Other two other girls, friend of Ms. Das were also in the spot. When the action was repeated, Mr. Kumbhang told Mr. Sen to avoid such behaviour on the girls. The girls also protested. In the meantime, a group of students from NMH gathered there and a clash was took place between Mr. Kumbhang and boarders of NMH. As per preliminary report, Mr. Kumbhang left the place along with the girls at around 9.30pm. After the show was over, a group of students from NMH gathered in front of NMH on the ring road at around 10.30pm. DSW along with other officials, faculty members rushed into the situation and at around 11.30pm, boarders of NMH entered to their hostel after an agreeable settlement with DSW, ADSW and other officials.

In the next day, at around 3.30pm in the DSW office the DSW informed to the members that he received apology letters on 25.02.2019 written by Mr. Kumbhang to Mr. Sen copy to DSW with a statement that he was interested to compromise the matter. It was accepted by Mr. Sen and added that he would not raise any complaint against Mr. Kumbhang in future. In another apology letter written by Mr. Sen addressed to Ms. Sweeta Das and Ms. Juri Saikia for any inconvenience caused by him to them by inappropriate manner which was not intentional. Ms. Sweeta Das was the girl student who complained to Mr. Sen that one of his feet was overlapped to her feet. Ms. Juri Saikia was also enjoying the performance of invited artist in the playground along with Ms. Das. Ms. Sweeta Das also wrote a letter to DSW that she had accepted the apology letter of Mr. Sen and stated that she would not raise any complaint against Mr. Sen in this matter. The apology letters were read out by the DSW before the committee.

After discussing the matter in detail, the committee recommended the following:

As the involved students in the incidents have come forward to do apologise the matter each other, the committee recommended for issuing strong warning letters to Mr. Sen and Mr. Kumbhang not to repeat such types of indiscipline activities inside the University campus. The committee also suggested to issue a letter to the girl students with an advisory that in such incidents in future, she should inform immediate the matter to the concerned authority on spot for appropriate action.

✓ **Incident 2-** Physical fighting between Mr. Arunabh Buragohain (Roll No. MSI 17010) and Pradipta Kalita (PHI16007)

Mr. Arunabh Buragohain, a boarder of CMH hostel was found smoking cigarette and consuming alcohol in the playground as reported. Mr. Pradipta Kalita of PMH who was in the ground along with his friends told Mr. Buragohain to stop such enraged behaviour in the field. After the function was over and students were proceeding to their respective hostels, Mr. Buragohain involved in fighting with Mr. Kalita and his friends at around 10.30pm. Later part of the development, boarders of PMH were gathered in front of PMH and found shouting against the misdeed of Mr. Buragohain, a boarder of CMH. On 27.02.2019, a letter from CMH was submitted to DSW complained against the behaviour of some PMH boarders to the boarders of CMH in that night.

After a threadbare discussion of above incidents, the committee recommended for constitution of an enquiry committee with the following members for further investigation on the unruly behaviour of the students.

Considering the above cases and also similar indiscipline activities frequently found among students, the committee would like to request the University on the followings:

1. An Alcohol detection device may be procured by the administration as the numbers of alcohol drinking cases are increasing consistently and disciplinary action against such offenders require such devises to ascertain the offense.
2. An Enquiry committee may be constituted to find out the channel from where the students get easy access to Alcohol/Drugs/Ganja etc. in the hostel.

As no other business to transact, the meeting ended with vote of thanks from and to the chair.







Mr. Rajesh Kumbang (Roll No. CSB14050), a final year B. Tech student, Department of Computer Science and Engineering, Tezpur University who was debarred from visiting any hostel during his period of study in the University as per office order no. TU/DSW/DC/15/12-10 dtd. 20.08.2016 was found in room no. 268 of Kanchanjungha Men's Hostel (KMH) on the night of 16<sup>th</sup> November, 2018 with a group of other boarders of the hostel hosting a drinking party. Mr. Kumbhang was also rusticated from the University for spring semester, 2018 as per office order no. TU/DSW/Disc/17-F.01/518-A dtd. 30.01.2018. Thus, Mr. Kumbang is found violating the hostel rules repeatedly despite several warnings issued by the disciplinary committee.

Based on the recommendations of Students Disciplinary Committee held on 27.12.2018, the competent authority has imposed a fine of Rs. 15,000/- (Rupees Fifteen Thousand) only as punitive action as per the clause 9.4.2 of the Hostel Rules 2015 on Mr. Rajesh Kumbang. Mr. Kumbang is asked to deposit the fine in the finance section TU within 15<sup>th</sup> April, 2019 and submit a copy of the receipt to the Office of the DSW.

The University has taken the note of the repeated breaching of discipline by Mr. Kumbhang and warned him to restrain from such activities in future, otherwise, University will take stricter actions as per rule.





Minutes of the Disciplinary Committee meeting held on 09.04.19 at 3.30 pm in the PPT room to discuss disciplinary matter of two boarders of Charaideo Men's Hostel

DSW Chaired the meeting and welcomed the members. He informed the members that the following two boarders of Charaideo Men's Hostel damaged some property of the university in the hostel in the night of 16<sup>th</sup> March, 2019 and at that time they were in alcoholic condition:

1. Mr Bhargav Kumar Das (Roll No. MEB16029) – B. Tech in Mechanical Engg
2. Mr. Bishal Pratim Das ( Roll No. ELB16060)- B. Tech in ECE

As per report of the Senior Warden and Prefect of the hostel, Mr. Bhargav Kumar Das and Mr. Bishal Pratim Das were found in drunken state at around midnight of 16<sup>th</sup> March, 2019. Mr. Bhargav Kr Das intentionally damaged three wash basins of the bath room No. 1 of the hostel under the alcoholic condition. Mr Keep Jyoti Baruah, Debajyoti Dutta and Kul Devid Barman, boarders of the hostel have witnessed the incident.

Mr. Bishal Pratim Das kicked the window pan and damaged the glasses. The Senior warden informed that he rushed to the hostel after coming to know the incident and he saw bleeding from the hand of Mr Bishal Pratim Das when he reached there. Immediately he sent him to the hospital for medical treatment.

The DSW reported that he served a show cause notice to both the offenders. On the basis of the show cause notice of the DSW dated 22.03.19, both of them admitted their offence vide their letter dated 25.03.19. The Senior Warden reported in the meeting that as per his instruction Mr. Bhargav Kumar Das replaced wash basins and Mr. Bishal Pratim Das replaced the window glass.

The committee after threadbare discussion and observed that they breached the hostel rules by drinking alcohol, creating nuisance in the hostel and damaging the University property.

As per the clause No. 9.3.5 and 9.3.6 of the Hostel Rules, 2015, the offence committed by them is a major one. Considering the gravity of the offence, the committee resolved to recommend the following punitive actions against them as per the clause no. 9.4 ( Actions against major offence) of the hostel Rules, 2015:

1. Both the offenders, Mr. Bhargav Kr Das and Mr. Bishal Pratim Das be rusticated from the hostel for current and next semester with immediate effect.
2. They be put on Conduct Probation for the duration of their rustication period from the hostel.
3. Copy of the office order be sent to their parents.





Dean Students' Welfare chaired the meeting and welcomed the members. He placed the report submitted by the enquiry committee constituted by the Disciplinary committee held on 27.02.2019 to inquire into the unruly behaviour, physical fighting and ruckus created by a group of students residing in CMH and PMH on the night of 24.02.2019; the date Cultural Night of the Annual Meet was held.

**Discussion:**

Based on the report of the enquiry committee, Mr. Arunabh Buragohain (Roll No: MSI 17010), a student of Int. Msc. in Maths was found involved in taking alcoholic beverages, indulging in misbehaviour, smoking inside the University campus in public place where the cultural night was enjoying by others and physically assaulted to fellow students. The report of the enquiry committee is placed herewith at F-I. The enquiry committee also reported that the behaviour of Vice-President and cultural secretary of TUSC were an act of unbecoming of their position in the student representative body. The Head of the Department of Mathematical Sciences pointed out that Mr. Arunabh Buragohain (Roll No: MSI 17010) had not been enrolled in the current semester. It was also supported by the evidence given by the CoE, TU. The Disciplinary committee summoned Mr. Buragohain in the meeting for cross verification and he appeared before the committee. He told that he did not register the course for Spring semester, 2019, but deposited the admission fee to Bank account and availing the hostel facility.

**Recommendation:**

The Disciplinary Committee accepted the report of enquiry committee. On the basis of recommendation of the enquiry committee and confession made by Mr. Buragohain, he was found guilty of breaching the hostel rules clause no. 9.3.1., and 9.3.5. The Disciplinary committee recommended the following punishable action as per the clause no.9.4.5 of the Hostel Rules, 2015:

- i) Mr. Buragohain be debarred from taking course registration in the next semester i.e. Autumn semester, 2019
- ii) He be asked to vacate the Hostel with immediate effect.



iii) The parents of Mr. Buragohain be informed of the offense committed by him and the punitive action taken by the University.

The Committee also noted the unexpected behaviour of TUSC members on the incident as reported by Enquiry Committee in its report and they were found breaching the hostel rules as per clause no. 9.1.12. The Disciplinary committee recommended as per clause no. 9.2 of the hostel rules that strong warning be given to Mr. Debraj Bora, Vice-President, TUSC and Mr. Prachurya Protim Sabhapandit, Cultural Secretary, TUSC to refrain from such unruly behaviour in future, which is indecent and unacceptable in case of an elected representative of student body. In case of any repetition, they will be asked to step down from the TUSC position.


The meeting was chaired by DSW. The DSW welcomed the members and discussed the following agenda.

**\* Case-I: Unauthorized stay in Patkai Men's Hostel by Mr. Dhruba Jyoti Konch ( Roll ESE18031), a student of the Department of Environmental Sc**

The Senior Warden of PMH has found that a student of first semester M.Sc in Environmental Science, named Mr. Dhruba Jyoti Konch ( Roll ESE18031), has been staying in the hostel without permission. When he was a student of B.Voc in Food Processing in the last semester he was allotted hostel accommodation. However, he took admission in MSc in Environmental Sc under Self Supported without formally withdrawing the seat from the B.Voc programme. As a student of Self supported Scheme (SSS) he was not allotted hostel seat at the time of admission, but when seat was available all such SSS students were allowed to take admission in the hostel. However, Mr. Konch continued to stay in the hostel occupying the same room without the knowledge of the hostel administration and did not take the hostel admission. After knowing the fact the DSW issued a show cause notice to Mr. Konch on 26.11.2018. In response to the show cause notice, Mr. Konch admitted his offense and apologized vide his letter dated 28.11.2018 (Annexure is placed at F-1). After threadbare discussion, the committee resolved as follows:

**Resolution:**

1. Mr. Dhruba Jyoti Konch be asked to deposit the hostel admission fee and caution deposit for the Autumn Semester, 2018 as the fee structure of SSS.
2. Mr. Konch be imposed a fine of Rs 2000/- due to his offense of unauthorized stay in the hostel.
3. Mr. Konch be accommodated in a hostel other than PMH on production of receipt of payment of fees of above sl. 1 and 2.

4. Stern warning letter be issued to Mr. Konch to refrain from such offense in future with a copy to his parents. Any reiteration of such offences will invite stricter disciplinary action as per University rule.

**Note:** Considering the above incident, the committee has noted that warden copies of enrollment card of the continuing students are failed to deposit to the Warden of the hostel at the beginning of each semester and it becomes difficult for the Warden to find out the genuine hostel boarders who have taken hostel admission. To avoid such difficulties in future, the meeting suggested the DSW to request the Heads of the Departments to send the Warden's copy of Enrolment card to the Office of the DSW within seven days from the Date of enrolment for verification of hostel admission of students.

#### **Case-II: Drinking of Alcohol by a group of students in the hostel**

Based on the report received from Senior Warden and Warden of KMH, DSW informed to the meeting that the following five students were found drinking alcohol in the room no. 268 of Kanchanjungha Men's Hostel ( KMH) at night of 16<sup>th</sup> November, 2018. This was found at the time of surprise visit of the Hostel Wardens. These students are :

1. Rajesh Kumbang ( Rollno. CSB14050), a student of B.Tech CSE
2. Ritupal Sarma ( Rollno. ELB14013) a student of B.Tech ECE
3. Ananta Kumar Mahanta ( Rollno. ELB14014) a student of B.Tech ECE
4. Akash Hazarika ( Rollno. CIB16075) a student of B.Tech Civil Engg
5. Dibyajyoti Kalita ( Rollno. CIB16046) a student of B.Tech Civil Engg

On receipt of the report from the Senior Warden, the DSW issued a show Cause Notice to those students for their misconduct and act of indiscipline inside the hostel. The students' reply in responses to the show cause notices were placed before the committee and the committee did not find them reasonably responded.

The committee noted that Mr. Rajesh Kumbang was involved in the act of indiscipline earlier in several cases and was rusticated from the hostel for remaining period of study and debarred from visiting any hostel during his period of study in the University as per office order no. TU/DSW/DC/15/12-10 dtd. 20.08.2016. Besides, Mr. Kumbang was rusticated from the University for Spring Semester, 2018 as per office order no. TU/DSW/Disc/17-F.01/518-A dtd. 30.01.2018.

Other four students are boarders of the KMH. However, Mr. Ritupal Sarma and Mr. Ananta Kumar Mahanta were also involved in breaching the hostel rules earlier and warned to refrain from indulging any act of indiscipline.

Mr. Ritupal Sarma was rusticated from the hostel for one semester i.e. Spring 2018 for reckless driving on the campus. Besides, Mr. Sarma was rusticated from the University for one semester i.e. Spring Semester, 2018 as he was found involvement in a ragging incident at KMH by Anti-ragging Committee as per office order no. F.18-27/1/2009 (Acad) dtd. 2<sup>nd</sup> January, 2018. In the last semester, based on his repeated appeals, competent authority allowed him to return to hostel with an

undertaking from him that he would not involve any indiscipline in future, otherwise, he was ready to face any disciplinary action.

Mr. Ananta Kumar Mahanta was also fined Rs 5000/- along with seven others students of KMH for taking *Marijuana* in the hostel as per notification of hostel Warden dtd. 07.10.2016.

Mr. Rajesh Kumbang and Mr. Ritupal Sarma are under conduct probation till date. They have again committed offense by drinking alcohol in the hostel and not complying the office orders issued earlier. There were no earlier records found on disciplinary actions against Mr. Dibyajyoti Kalita and Mr. Akash Hazarika.

**After thread bare discussion the committee imposed following punitive actions.**

**I. Action to Mr Rajesh Kumbang:**

1. Mr Rajesh Kumbang be fined a sum of Rs 25,000/- for his repeated breach of hostel Rules and violation of office orders of the University. (KA)
2. Notification with his photograph prohibiting Mr. Kumbang to visit any hostel be sent to all hostels. One copy may also be given to the security of Main Gate.


**\* II. Action to Mr Ritupal Sarma and Mr. Ananta Kumar Mahanta :**


1. Both Mr Ritupal Sarma and Mr. Ananta Kumar Mahanta be rusticated from the hostel for remaining period of their study.
