

Minutes of the meeting of the Disciplinary Committee meeting held on 08 April 2021 at 3.30pm in the Board Room


Prof. Dhanapati Deka, DSW & Chairperson of the committee welcomed all members and appraised the members about the purpose of the meeting. The Chairman informed to the members that 2 boys and 3 girls students of the University were found to visit Dirang, Arunachal Pradesh without taking permission from Concerned authority during April 2-6, 2021. The students are:

1. Mr. Runanka Roy (rollno. CSB17019)
2. Mr. Pragya Sankar (Rollno.MEB17024)
3. Ms. Vandana Goyari (Rollno. ELB17064)
4. Ms. Sucharia Mondal (Rollno.MEB17058)
5. Ms. Sushmita Mishra (Rollno.ELB17071)

Mr. Runanka Roy (Rollno. CSB17019) and Mr. Pragya Sankar (Rollno.MEB17024) are from Patkai Men's Hostel(PMH), Ms. Vandana Goyari (Rollno. ELB17064) and Ms. Sucharia Mondal (Rollno.MEB17058) are from Bordoichila women's Hostel (BWH) and Ms. Sushmita Mishra (Rollno.ELB17071) is from Pragjyotika Women's Hostel (PWH). All of them are pursuing B.Tech in 8th Semester.

The DSW requested the Wardens of Concerned hostels to narrate the matter before the members. Dr. Nabin Sarmah, Senior Warden of the PMH reported that a rented car came to PMH with some students during his visit to PMH on 2nd April' 21 at about 6.00 p.m. Two students got down from the car with bag and baggage. He inquired them about their arrival. At the first instance, they told him that they went home for casting vote in the Assembly election. He, then, asked them to show the mark of indelible ink in the finger given at the time of casting the vote. They could not show the mark and then they tried to convince him narrating other stories.

At night about 10.00 p.m. in the same day, Dr Nabin Sarmah visited the hostel again with Prof.D.Deka, DSW and Prof. M. Mandal, ADSW. After interaction with them, they confessed



that they went to Dirang, Arunachal Pradesh on 2nd April with three girl students and came back to the campus on 6th April, 2021. The DSW, ADSW and Sr. Warden visited the PWH and BWH and enquired the accused girls in presence of the caretaker of the hostel. On enquiry, the girl students also confessed that they took permission to go home but they did not go to their homes, rather they went to Dirang, Arunachal Pradesh. All of them gave written statements to their wardens about their visit to Dirang, Arunachal Pradesh who in turn forwarded it to the DSW.

It may be noted that after coming back from the trip, the above-mentioned boarders stayed in the hostel without any COVID test report. But, as advised by the DSW, they did RAT test in the next day and submitted RAT negative report in the hostel.

The committee noted that they not only violated the clause no. 1.14.2.5 of the Hostel Rules 2019, by staying outside overnight and remaining unauthorized absence from Hostel which is an act of indiscipline/offense, but also breached the Covid-19 SOP of Hostel issued by the DSW that they are not to leave the University campus without permission whatsoever is the reason.

In this regard, when the students returned to the campus, they submitted an undertaking duly signed by them and their parents that they will follow the Covid-19 Protocol and will not leave the University until further notice is issued by the Competent authority. They have not followed their own commitment.

After a threadbare discussion, the committee found guilty of them as they violated the Covid-19 Protocol and brought threat of Covid-19 to their fellow boarders and other University members in addition to the violation of Hostel rules, **and recommended the following penalties:**

1. All the five boarders viz., Mr. Runanka Roy, Mr. Pragya Sankar, Ms. Vandan Goyari Ms. Sucharia Mondal and Ms. Sushmita Mishra be issued stern warning for their misconduct as per clause No. 1.15.2 of the Tezpur University Hostel Rules 2019.
2. The hostel accommodation to all five boarders be withdrawn for the current semester due to breach in Covid-19 protocol and violation of Hostel SOP. The DSW be requested to intimate their parents to take back their wards from the hostel immediately and
3. Stricter action be imposed as per rule if they get involved in any indiscipline activity in future.

Further, the committee requested the DSW to hold a discussion with all Wardens (especially for boys' hostels) to evaluate an effective mechanism for regulate the hostel boarders attendance.

The meeting ended with vote of thanks from and to the Chair.
