At the outset of the meeting, the Vice-Chancellor expressed his greetings to all the members and apprised about the recent achievements of the University. He informed that the Times Higher Education (THE) Emerging Economies University Rankings 2018, ranked the University in 99th position. THE considered institutions from the 50 countries but the institutions of 42 countries only made the final top of the list of 378 institutions. He congratulated all the faculty members and staff and appealed to all of them to continue with their hard work to scale greater heights in the coming years. The Vice - Chancellor also congratulated Prof. A.K. Mukherjee for



receiving Visitor's Award for Best Research 2018 and Prof. Niranjana Karak for being awarded with the prestigious Fellow of the Royal Society of Chemistry (FRSC) in recognition of his contribution to the field of Chemistry. He informed that the University has been short listed by the UGC for the Intuitions of Eminence, but final out come is yet to come. 


