Option for Lateral Exit/Continuation: The Students of the 6th semester Integrated M.Com. Programme, who opt for lateral exit option, shall be provided with B.Com.(Major) certificate on successful completion of all requirements till 6th semester of the programme. The students who opt for continuing the study, but fail to take admission in the 7th semester will have to pay a processing fee equal to the amount of the admission fee(i.e Rs.18,303/-) to make them possible for obtaining the B.Com (Major)certificate, if otherwise found eligible. 2. TUEE Module: There will be two separate tests viz. one for entry to First Semester i.e B.Com module for 10+2 pass-out candidates and another for entry to the seventh Semester i.e. M.Com module for B.Com(Hons/Major)graduates candidates. 2. Intake: Out of the total 30 intake of the Integrated M.Com programme, total 19 (Nineteen) students of the Int. M. Com programme (6th semester) have submitted the option to continue their study and 11 students have opted to discontinue. The intake for entry into the 7th Semester of Integrated M.Com programme (for M.Com module) may be taken as 11(eleven) for the academic session 2017-18. <p style="text-align: center;">Additional 2(two) seats may be offered as Self support Seats (SSS) for the M. Come module and students who had taken admission at SSS may be converted to normal seats from seventh Semester onwards, if they choose to continue the programme.
