The Mentor was also given the opportunity to guide the Mentees for Project I, through which the Mentor could be in touch with the Mentees on a regular basis through online mode.


The commonly asked queries were with regard to the physical presence of the students in the campus.

- i) All the mentees were informed about need for focus attention towards their studies and at the same time bring in to the attention of the mentor regarding difficulties, if any.
- ii) Since this batch of students are learning their lessons through online mode due to epidemic constraints, mentees were specifically told to discuss with the mentor about challenges of the virtual environment.
- iii) As research plays a significant role in post-graduate studies, all the mentees were asked to develop an aptitude for research from the very first semester itself. In that regard, research project was emphasized to be taken with utmost sincerity.
- iv) Mental well being of the mentees was given special attention through regular communication via telephone, whatsapp , email etc.

Semester II: 2021 Spring Semester

- i) Academic performance in the last semester was individually discussed and areas needing improvement were pointed out.
- ii) Some of the mentees were also told to improvise on their writing skills as was evident from examination papers to be needing improvement.
- iii) In research projects, some mentees were also found to be insufficiently reviewing existing literature. This aspect was highlighted. At the same time, ethical and original writing was specifically emphasized.

iv) Discussion about critical legal thinking was initiated with each mentee. Each of them was also guided on making their various presentation assignments reflective of the critical insights.
