OFFICE ORDER

Dr. Arup Roy, son of Mr. Deepak Roy, is appointed Associate Professor in the Department of Business Administration under the School of Management Sciences, Tezpur University, on the following terms and conditions:

1. The post is permanent and carries the Pay Band-4 : Rs.37400 – 67000/- plus Academic Grade pay of Rs. 9000/- and other allowances admissible as per Government of India rules.
2. Initial basic pay shall be fixed as per Government of India rules.
3. He shall be on probation for a period of 12 (twelve) months from the date of his joining, which may be extended for a further period of 12 (twelve) months. During the period of probation his services may be terminated at any time without assigning any reason thereof.
4. His service shall be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time and he shall be required to execute a Service Agreement (in duplicate) in a Non-Judicial Stamp Paper of Rs.20/- (each) at the time of joining the post.
5. His service will be governed by the CCS (Pension) Rules/ CPF/New Pension Scheme, whichever is admissible under Government of India rules.
6. He shall be amenable to accepting any other responsibility and executing any other task assigned by the University as and when required.
7. The appointment is provisional and subject to verification of the SC certificate by the appropriate authority. If, on verification, the claim of the candidate as belonging to the SC category is found to be not correct, the service of the candidate will be terminated and/or the appointment will be withdrawn as the case may be.
8. He shall be required to confirm acceptance of this offer in writing within 15 days and join duty within one month from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that he is not interested in this offer and the offer shall stand withdrawn.
