1. The post is permanent and carries the pay band of Rs.15600-39100 plus Academic Grade pay of Rs.6000/- and other allowances admissible as per Govt. of India rules.
2. Initial basic pay will be fixed as per Govt. of India rules.
3. His services will be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time.
4. The appointment is provisional and subject to verification of the caste certificate / certificate of disability in case of Persons with Disability (PWD) by the appropriate authority. If the verification reveals that the claim of the candidate as belonging to SC/ST/OBC/Persons with Disability is false, the service of the candidate will be terminated without assigning any further reason(s) and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate
5. He will be required to confirm acceptance of this offer in writing **within 15 days** from the date of issue of this order and to **join duty within one month** from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that he is not interested in this offer and the offer shall stand withdrawn.
6. The appointment is subject to production of certificate of fitness from the District Medical & Health Officer or a Government Medical Officer of equivalent status or Chief Medical Officer of Tezpur University
7. He will be required to submit all relevant documents in original and release order from his present employer.
