

OFFICE ORDER

Dated January 17, 2013

Dr. Sajal Kumar Das, son of **Mr. Sunil Kumar Das**, is appointed **Assistant Professor** in the **Department of Chemical Sciences** under the **School of Sciences**, Tezpur University, on the following terms and conditions:

1. The post is permanent and carries the **Pay Band-3 of Rs. 15600-39100 plus Academic Grade pay of Rs. 6000/-** and other allowances admissible as per Government of India rules.
2. Initial basic pay shall be fixed as per Government of India rules.
3. He shall be on probation for a period of 12 (twelve) months from the date of his joining, which may be extended for a further period of 12 (twelve) months. During the period of probation his services may be terminated at any time without assigning any reason thereof
4. His service shall be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time and he shall be required to execute a service agreement (in duplicate) in a non-judicial stamp paper of Rs.20/=(each) at the time of joining the post.
5. His service be governed by the provisions under the New Pension Scheme of Government of India as applicable to Central Government employees who have joined on or after 1.1.2004.
6. He shall be amenable to accepting any other responsibility and executing any other task assigned by the University as and when required.
7. The appointment is provisional and subject to verification of the **OBC (NCL) certificate** by the appropriate authority. If, on verification, the claim of the candidate as belonging to the OBC category is found to be not correct, the service of the candidate will be terminated and/or the appointment withdrawn as the case may be.
8. He shall be required to confirm acceptance of this offer in writing **within 15 days** from the date of issue of this order and **join duty within one month** from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that he is not interested in this offer and the offer shall stand withdrawn.
9. The appointment is subject to production of certificate of fitness from the District Medical and Health Officer or a Government Medical Officer of equivalent status or the Chief Medical Officer of Tezpur University.
10. He shall be required to produce all relevant documents in original including release order (if applicable) at the time of joining the post.


