3. He will be on probation for a period of 12 (twelve) months from the date of his joining, which may be extended for a further period of 12 (twelve) months.
4. His services will be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time.
5. He will be governed under the New Pension Scheme of Government of India as applicable to Central Government employees who have joined on or after 1.1.2004.
6. He will be required to confirm acceptance of this offer in writing **within 15 (fifteen) days** from the date of issue of this order and to **join duty within one month** from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that he is not interested in this offer and the offer shall stand withdrawn.
