OFFICE ORDER

Sri Loitongbam Basantakumar Singh, son of Sri Loitongbam Mukunda Singh, is appointed **Lecturer** in the Department of **Computer Science & Engineering**, under the **School of Engineering**, Tezpur University, on the following terms and conditions:

1. The post is permanent and carries the scale of pay of Rs. 8000- 275-13500/- (pre-revised) and other allowances admissible as per Govt. of India rules.
2. Initial basic pay will be fixed as per Govt. of India rules.
3. He will be on probation for a period of 12 (twelve) months from the date of his joining, which may be extended for a further period of 12 (twelve) months
4. His services will be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time and he will be required to execute a service agreement (in duplicate) in a non-judicial stamp paper of Rs.10/- (each) at the time joining the post
5. The appointment is provisional and subject to verification of the caste certificate. If the verification reveals that the claim of the candidate as belonging to OBC category is false, the service of the candidate will be terminated without assigning any further reason(s) and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.
6. The appointment is subject to production of certificate of fitness from the District Medical & Health Officer or a Government Medical Officer of equivalent status or Chief Medical Officer of Tezpur University
7. He will be required to confirm acceptance of this offer in writing **within 15 days** from the date of issue of this order and to **join duty within one month** from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that he is not interested in this offer and the offer shall stand withdrawn.
8. He will be required to submit all relevant documents in original.
