## ORDER

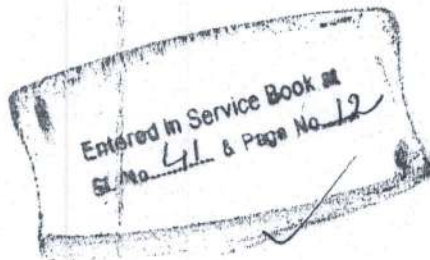
