## OFFICE ORDER

**Dr.(Mrs.) Farheena Ahmed Danta**, Reader, Department of English, Dibrugarh University, Dibrugarh-786004, is appointed **Professor** in the **Department of English and Foreign Languages** under the **School of Humanities and Social Sciences**, Tezpur University, on the following terms and conditions:

1. The post is permanent and carries the pay band of Rs.37400-67000 plus Academic Grade pay of Rs.10000/- and other allowances admissible as per Govt. of India rules.
2. Initial basic pay will be fixed as per Govt. of India rules.
3. Her services will be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time and she will be required to execute a service agreement (in duplicate) in a non-judicial stamp paper of Rs.10/- (each) at the time of joining the post.
4. She will be on probation for a period of 12 (twelve) months from the date of her joining, which may be extended for a further period of 12 (twelve) months
5. The appointment is subject to production of certificate of fitness from the District Medical & Health Officer or a Government Medical Officer of equivalent status or Chief Medical Officer of Tezpur University
6. She will be required to confirm acceptance of this offer in writing **within 15 days** from the date of issue of this order and to **join duty within one month** from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that she is not interested in this offer and the offer shall stand withdrawn.
7. She will be required to submit all relevant documents in original including release order from her previous organization.
