OFFICE ORDER

Ms. Bipasha Patgiri, daughter of Mr. Robin Patgiri, is appointed Assistant Professor for the Programme of Linguistics in the Department of English & Foreign Languages under the School of Humanities and Social Sciences, Tezpur University, on the following terms and conditions.

1. The post is permanent and carries the Pay Band of Rs. 15600-39100/- plus Academic Grade pay of Rs.6000/- and other allowances admissible as per Government of India rules.
2. Initial basic pay will be fixed as per Government of India rules.
3. She will be on probation for a period of 12 (twelve) months from the date of her joining, which may be extended for a further period of 12 (twelve) months. During the period of probation her services may be terminated at any time without assigning any reason thereof.
4. Her service will be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time and **she will be required to execute a Service Agreement (in duplicate) in a Non-Judicial Stamp Paper of Rs.20/- (each) at the time of joining the post.**
5. She shall be required to accept any other responsibility and execute any other task as assigned by the University from time to time.
6. Her service will be governed by the provisions under the New Pension Scheme of the Government of India as applicable to the Central Government employees who have joined on or after 1.1.2004.
7. She will be required to confirm acceptance of this offer in writing **within 15 days** from the date of issue of this order and to **join duty within one month** from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that she is not interested in this offer and the offer shall stand withdrawn.
8. The appointment is subject to production of certificate of fitness from the District Medical and Health Officer or a Government Medical Officer of equivalent status or the Chief Medical Officer of Tezpur University
9. She will be required to produce all relevant documents in original including the Release Order (if applicable) from her previous organization.
