ORDER

Dr. (Mrs.) Poonam Mishra, D/o Mr. S. C. Mishra, is appointed **Associate Professor, Department of Food Engineering & Technology**, School of Engineering, Tezpur University, on the following terms and conditions.

1. The post is permanent and carries the **Pay Band 4: Rs. 37,400-67,100/- plus Academic Grade Pay of Rs. 9,000/-** and other allowances admissible as per Govt. of India rules.
2. Basic pay will be fixed as per Govt. of India rules (with pay protection if required and admissible as per rule).
3. Her services shall be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time and she shall be required to **execute a Service Agreement** (in duplicate) in a Non-Judicial Stamp Paper of Rs.20/- (each) at the time of joining the post.
4. Her services shall continue to be regulated by the provisions under the **New Pension Scheme** of Government of India as applicable to Central Government employees who have been appointed on or after 01.01.2004.
5. She shall be amenable to accepting any other responsibility and executing any other task assigned by the University as and when required.
6. She will be required to **confirm acceptance** of this offer in writing **within fifteen (15) days** from the date of issue of this order and to **join duty within thirty (30) days** from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that she is not interested in this offer and the offer shall stand withdrawn.
7. She will be required to submit technical resignation from the post of Assistant Professor she is holding at the time of joining.
