ORDER

Ms. Daveirou Lanamai, D/o Sri Victor Lanamai & Smti. Chakhiakwiliu Lanamai, is appointed **Assistant Professor, Department of Foreign Languages**, School of Humanities & Social Sciences, Tezpur University, on the following terms and conditions:

1. The post is permanent and carries the **Academic Level 10 with Rationalised Entry Pay of Rs. 57,700/-** (Pre-revised PB-3: Rs. 15,600-39,100/- plus Academic Grade Pay of Rs. 6,000/-) and other allowances admissible as per Govt. of India rules.
2. Basic pay will be fixed as per Govt. of India rules (with pay protection if required and admissible as per rule).
3. She will be on **probation initially for a period of 12 (twelve) months** from the date of her joining, which may be extended for a further period of 12 (twelve) months. During the period of probation, her services may be terminated without assigning any reason thereof. Further, confirmation in service is also subject to satisfactory Police Verification Report.
4. Her services shall be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time and she shall be required to **execute a Service Agreement** (in duplicate) in a Non-Judicial Stamp Paper of Rs.20/- (each) at the time of joining the post.
5. Her services shall be regulated by the provisions under the **New Pension Scheme** of Government of India as applicable to Central Government employees who have been appointed on or after 01.01.2004.
6. She shall be amenable to accepting any other responsibility and executing any other task assigned by the University as and when required.
7. The appointment is subject to production of certificate of fitness from the District Medical & Health Officer / Government Medical Officer of equivalent status or Chief Medical Officer of Tezpur University.
8. The appointment is provisional and subject to verification of all original certificates/documents (including Caste/Category, Disability Certificates) issued by the appropriate authority. If on verification, the claim of the candidate with respect to the academic qualifications and other requirements as per the concerned advertisement is/are found to be not correct, the service of the candidate will be terminated and / or the appointment withdrawn, as the case may be.
9. She will be required to **confirm acceptance** of this offer in writing **within fifteen (15) days** from the date of issue of this order and to **join duty within thirty (30) days** from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that she is not interested in this offer and the offer shall stand withdrawn.
10. She will be required to submit all relevant documents in original including release order from her previous organization and other necessary papers such as Last Pay Certificate (clearly mentioning the scheme of Provident Fund/Pension Scheme/NPS, etc.), if already in employment, at the time of joining.
