ORDER

Dr. Tapan Kumar Gogoi, S/o Late Bhadreswar Gogoi, is appointed Professor, Department of Mechanical Engineering, School of Engineering, Tezpur University, on the following terms and conditions.

1. The post is permanent and carries the Pay Band 4: Rs. 37,400-67,000/- plus Academic Grade Pay of Rs. 10,000/- and other allowances admissible as per Govt. of India rules.
2. Basic pay will be fixed as per Govt. of India rules (with pay protection if required and admissible as per rule).
3. He will be on probation initially for a period of 12 (twelve) months from the date of his joining, which may be extended for a further period of 12 (twelve) months. During the period of probation, his services may be terminated without assigning any reason thereof.
4. His services shall be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time and he shall be required to execute a Service Agreement (in duplicate) in a Non-Judicial Stamp Paper of Rs.20/- (each) at the time of joining the post.
5. He shall be amenable to accepting any other responsibility and executing any other task assigned by the University as and when required.
6. He will be required to confirm acceptance of this offer in writing within fifteen (15) days from the date of issue of this order and to join duty within thirty (30) days from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that he is not interested in this offer and the offer shall stand withdrawn.
7. He will also have to resign (which will be treated as Technical Resignation) from the post of Associate Professor (and hence his original position of Assistant Professor) which he is holding currently.
