OFFICE ORDER

Mr. Rakesh Bhadra, S/o Mr. Raimohan Bhadra, is appointed Assistant Professor, Department of Mechanical Engineering, School of Engineering, Tezpur University, on the following terms and conditions:


1. The post is permanent and carries the **Pay Band 3: Rs. 15,600-39,100/- plus Academic Grade Pay of Rs. 6,000/-** and other allowances admissible as per Govt. of India rules.
2. Basic pay will be fixed as per Govt. of India rules.
3. He will be on **probation initially for a period of 12 (twelve) months** from the date of his joining, which may be extended for a further period of 12 (twelve) months. During the period of probation, his services may be terminated without assigning any reason thereof.
4. His services shall be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time and he shall be required to **execute a Service Agreement** (in duplicate) in a Non-Judicial Stamp Paper of Rs.20/- (each) at the time of joining the post.
5. His services will be regulated by the provisions under the **New Pension Scheme** of Government of India as applicable to Central Government employees who have been appointed on or after 01.01.2004.
6. The appointment is provisional and subject to verification of the **Scheduled Caste (SC)** certificate. If, on verification, the claim of the candidate as belonging to SC is found to be false, the service of the candidate shall be terminated and / or the appointment withdrawn as the case may be.
7. He shall be amenable to accepting any other responsibility and executing any other task assigned by the University as and when required.
8. The appointment is subject to production of certificate of fitness from the District Medical & Health Officer / Government Medical Officer of equivalent status or Chief Medical Officer of Tezpur University.
9. He will be required to **confirm acceptance** of this offer in writing **within fifteen (15) days** from the date of issue of this order and to **join duty within thirty (30) days** from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that he is not interested in this offer and the offer shall stand withdrawn.
10. He will be required to submit all relevant documents in original including release order from his previous organization, if already in employment, at the time of joining.
