ORDER

Dr. Vivek Kumar Mehta, S/o Sri Rajendra Kumar Mehta, is appointed Assistant Professor, Department of Mechanical Engineering, School of Engineering, Tezpur University, on the following terms and conditions.

1. The post is permanent and carries the Pay Band 3: Rs. 15,600-39,100/- plus Academic Grade Pay of Rs. 6,000/- and other allowances admissible as per Govt. of India rules.
2. Basic pay will be fixed as per Govt. of India rules (with pay protection if required and admissible as per rule).
3. He will be on **probation initially for a period of 12 (twelve) months** from the date of his joining, which may be extended for a further period of 12 (twelve) months. During the period of probation, his services may be terminated without assigning any reason thereof. Further, confirmation in service is also subject to satisfactory Police Verification Report.
4. His services shall be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time and he shall be required to **execute a Service Agreement** (in duplicate) in a Non-Judicial Stamp Paper of Rs.20/- (each) at the time of joining the post.
5. His services shall be regulated by the provisions under the **New Pension Scheme** of Government of India as applicable to Central Government employees who have been appointed on or after 01.01.2004.
6. He shall be amenable to accepting any other responsibility and executing any other task assigned by the University as and when required.
7. The appointment is subject to production of certificate of fitness from the District Medical & Health Officer / Government Medical Officer of equivalent status or Chief Medical Officer of Tezpur University.
8. He will be required to **confirm acceptance** of this offer in writing **within fifteen (15) days** from the date of issue of this order and to **join duty within thirty (30) days** from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that he is not interested in this offer and the offer shall stand withdrawn.
9. He will be required to submit all relevant documents in original including release order from his previous organization and other necessary papers such as Last Pay Certificate (clearly mentioning the scheme of Provident Fund/Pension Scheme/NPS, etc.), if already in employment, at the time of joining.


