OFFICE ORDER

Mr. Eeshan Kalita, Son of Dr. Shyamal Kalita, is appointed **Lecturer** in the Department of Molecular Biology & Biotechnology under the School of Science & Technology, Tezpur University, on the following terms and conditions:

1. The post is permanent and carries the scale of pay of Rs. 8000-275-13500/- and other allowances admissible as per Government of India rules.
2. Initial basic pay will be fixed as per Government of India Rules.
3. He will be on probation initially for a period of 12 (twelve) months, which may be extended by a further period of 12 (twelve) months. During the period of probation, his service may be terminated without assigning any reason thereof.
4. His services will be regulated by Tezpur University Act, 1993, Statutes and Ordinances and Rules and Regulations of the University in force from time to time.
5. The appointment is provisional and is subject to verification (if applicable) of the caste certificate / certificate of disability in case of Persons With Disability by the appropriate authority. If the verification reveals that the claim of the candidate to belong to SC/ST/OBC/Persons With Disability is false, the service of the candidate will be terminated without assigning any further reason(s) and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.
6. Medical Fitness: This appointment is subject to production of medical certificate of fitness from the District Medical & Health Officer / Government Medical Officer of equivalent status or Senior Medical Officer of Tezpur University.
7. He will be required to **confirm acceptance** of this offer in writing **within 15 days** from the date of issue of this order and **join duty within one month** from the date of issue of this order. If no communication accepting the offer is received within the said period, it will be assumed that he is not interested in this offer and the offer shall be treated as withdrawn.
8. He will be required to submit all relevant documents in original including release order (if applicable) from his previous organization.
