





OFFICE ORDER
Dated 28 / 07 / 2011

Mr. Nima Dondu Namsa, son of **Mr. Norbu Jatso Namsa**, is appointed **Assistant Professor** in the Department of **Molecular Biology & Biotechnology** under the **School of Science & Technology**, Tezpur University, on the following terms and conditions:

1. The post is permanent and carries the Pay Band of Rs. 15,600-39,100/- (PB-3) plus Academic Grade pay of Rs. 6,000/- and other allowances admissible as per Government of India rules.
2. Initial basic pay will be fixed as per Government of India rules.
3. He will be on probation for a period of 12 (twelve) months from the date of his joining, which may be extended for a further period of 12 (twelve) months.
4. His services will be regulated by the Tezpur University Act, 1993 and Statutes, Ordinances, Rules and Regulations of the University in force from time to time and he will be required to execute a service agreement (in duplicate) in a non-judicial stamp paper of Rs.20/- (each) at the time of joining the post.
5. He will be governed by the CCS (Pension) Rules / CPF / New Pension Scheme which ever is admissible under Government of India rules.
6. The appointment is provisional and subject to verification of the caste certificate / certificate of disability in case of Persons with Disability (PWD) by the appropriate authority, if applicable. If, on verification, the claim of the candidate as belonging to SC/ST/OBC(NCL)/Persons with Disability is found to be false, the service of the candidate will be terminated and / or the appointment withdrawn as the case may be.
7. He will be required to confirm acceptance of this offer in writing **within 15 days** from the date of issue of this order and to **join duty within one month** from the date of issue of this order. If no communication accepting this offer is received within the said period, it will be assumed that he is not interested in this offer and the offer shall stand withdrawn.
8. The appointment is subject to production of certificate of fitness from the District Medical and Health Officer or a Government Medical Officer of equivalent status or the Chief Medical Officer of Tezpur University.
9. He will be required to produce all relevant documents in original including release order (if applicable) from his previous organization at the time of joining.


